

HOLD HARMLESS RELEASE FORM

For and in consideration of participation in activities at Sylvia’s Clubhouse, we, the undersigned, on our own behalf and on behalf of our child(ren), heirs, executors, administrators, successors and assigns, hereby irrevocably, unconditionally, and forever release, waive, and hold harmless Sylvia’s Clubhouse, LLC, its members, employees, agents, successors and assigns of and from any and all actions, claims, demands, damages, losses, injuries, including serious injuries, death, costs, charges, and/or liabilities of any nature whatsoever that the undersigned (and/or his/her/their child(ren), heirs, executors, administrators, successors and assigns) now has/have or which may hereafter accrue whether due to the negligence of Sylvia’s Clubhouse’s members, employees, agents and/or assigns, pertaining to or in any way arising out of the individual(s) named below, use of equipment or the participation in any activities anywhere upon the property of Sylvia’s Clubhouse.

In addition, we, the undersigned, on our own behalf and on behalf of ourself(ves), our child(ren), heirs, executors, administrators, successors and assigns, covenant to indemnify, defend, and hold harmless Alden Land Trust and its members, employees, agents, successors and assigns from and against all actions, claims, demands, damages, losses, injuries, serious injuries, death, costs, charges, and/or liabilities of any nature whatsoever pertaining to or in any way arising out of the child(ren) named below, whether due to the negligence of Sylvia’s Clubhouse’s members, employees, agents and/or assigns, use of the equipment or participation in any activities anywhere upon the property of Sylvia’s Clubhouse.

Further, we, the undersigned, on our own behalf and on behalf of ourself(ves) our child(ren), heirs, executors, administrators, successors and assigns, covenant to:

- a. Abide by all rules, regulations and conditions posted upon the premises;
- b. Comply with all verbal instructions from staff members at all times while upon the premises;
- c. Grant permission for Sylvia’s Clubhouse to photograph any or all of the below named individuals for use in promotional advertisements, flyers or website content;
- d. Pay to Sylvia’s Clubhouse any and all damages caused by any participant named below; and,
- e. If, at the discretion of Sylvia’s Clubhouse house any member or guest fails to comply with these rules, regulations or verbal instructions, they will be asked to leave Sylvia’s Clubhouse immediately and no refund of any fees will be made.
